### **2. What is covered by this privacy notice?**

How we process your personal data, the legal basis for processing such data and your rights.

### **3. What is personal data & what data is processed?**

Personal data is any information that enables you to be identified.

Personal data processed by VSMPO Tirus Limited covers your name, contact details, work address, and any other details required for business purposes.

### **4. What are your rights?**

Under GDPR, you have the following rights which we will always work to uphold:

- a) The right to be informed about our collection, reception and use of your personal data.
- b) The right to access the personal data we hold about you
- c) The right to have your personal data rectified if any of your personal data held by us is inaccurate or incomplete.
- d) The right to be forgotten
- e) The right to restrict (i.e. prevent) the processing of your personal data.
- f) The right to object to us using your personal data for a particular purpose or purposes.
- g) The right to data portability
- h) Rights relating to automated decision-making and profiling

**8. How can you access your personal data “subject access request”?**

You can ask in writing for details of your personal data, the category of documents they are in, and if necessary and applicable a copy. We have the right to request a £10 fee for administration. We will respond to your subject access request within 40 calendar days, as mandated by the ICO.
